BIKE RENTAL AGREEMENT

The person named above is renting a bicycle and/or participating in a tour from Bike It! Bellagio.

The renter must show a valid identification (e.g., passport, driver's license) document to rent a bicycle.

1. When the renter receives the bicycle without making any observations or objections, he/she recognizes that the bicycle is perfectly functional. The renter declares, under his/her own responsibility, that he/she is capable of using the rented bicycle without hazard to himself/herself or to others. If the renter is an adult, he/she may rent a power-assisted vehicle limited to 250W, 625W or 800W, for which no qualification, license, or driver's license is required. In no case may the renter transfer its use to another person.
2. Use of a helmet is mandatory. The helmet must be firmly latched under the chin to prevent it from slipping or being lost in the event of accident. No form of compensation shall be claimed from Bike It! Bellagio for damage caused or suffered by the renter.
3. The renter agrees to use the bicycle with extreme caution and in full compliance with the Rules of the Road and is obliged to cover any costs resulting from the infractions for which he/she might be liable. The bicycle must be used by just one person. Bike It! Bellagio may refuse to rent the bicycle to persons who are deemed incapable of using or unprepared to use the bicycle. **The renter authorizes Bike It! Bellagio to charge the credit card on file for the reservation to compensate for any damages incurred during rental.**
4. The renter must use and safeguard the vehicle in such a way as to avoid damage and theft both to the bicycle and to its accessories. Bike It! Bellagio may request payment for the damage and/or broken parts caused or suffered by the bicycle, and replacement value of the bike if stolen or totaled.
5. Bike It! Bellagio offers the use of bike locks, without charge, to renters. Even when using a bike lock, renters should keep bikes in their line of sight, as bicycles are particular targets of theft in Italy. Please request a bike lock for use at the time of bike pickup.
6. If the bicycle is stolen, the renter must (a) immediately notify Bike It! Bellagio by calling +39 334 975 1604, (b) pay an amount ranging from €500.00 to €6,000.00 (according to the type and value of the rented bicycle), (c) report the theft to local police, and (d) provide a copy of the police report. The aforesaid amount will be returned if the bicycle is found.
7. **A rental day is 9:00 to 18:00, not 24 hours. The bicycle (and accessories or other rented items) shall be returned to later than 18:00 on the rental end date or it will be subject to an additional one-day charge.** Failure to return the bicycle on time without giving advance notice thereof shall be considered theft and consequently reported to law enforcement authorities. The bike and accessories must be returned within Bike It! Bellagio's operating hours unless another time/location is otherwise agreed upon.
8. Use of electric bicycles (power-assisted) is restricted to adults unless the minor is accompanied by an adult who assumes written liability for the damage that the minor might cause, exempting Bike It! Bellagio from all liability in this case, and who shall also constantly monitor the minor's behavior on the bicycle.
9. If the renter is also renting any devices or other items, the aforesaid terms regarding damage and theft likewise apply to any such devices or other items.
10. **The renter certifies that he/she has sufficient health, accident, and liability insurance to cover any injury or damage that he/she may incur while participating in this activity and to cover any injury or damage caused to a third party as a result of the renter's participation in the activity. The Renter certifies that if he/she has**

no such insurance, that Renter is capable of and will personally pay for any and all such expenses or liability.

11. The renter's signature below implies that the renter has read, understands, and agrees to the terms of the rental agreement as stated herein.
